**II. Opening remarks**

Gary Anderson opened the meeting by welcoming the new incoming Regional Elite Chairman from Region VIII, Toni Rand. He also informed the committee that Tony Retrosi is resigning his position as Region VI's Regional Elite Chairman.

Gary stated that at the recent Administrative Board meeting, it was discussed that the TOP position is an appointed position and should not be an elected position. The Regional TOP position is appointed by the Regional Elite Chairman.

**III. Regional Reports**

Each Region gave a brief regional report of events that took place in their region concerning the elite program. All Regional Chairmen indicated that the Pre-Elite program has worked well with in their region. It proved to be a very positive experience and a good developmental program into the elite program.

**IV. Qualification score change for the 2005 season to the Challenge**

**Recommendation the following changes qualification scores be made for the 2005 season.**

TOP Compulsory – 31.00  
 Junior Pre-Elite Optional – 32.00

**V. National Qualifiers**

**Recommendation to the IEC that 6 National Qualifiers be offered throughout the nation and the qualifiers sites be awarded by September 1, 2004.**

**Recommendation to the IEC that a Regional Elite International Qualifier be permitted to be held on the same date as a National Elite Qualifier.**

*\* The IEC voted to allow International Regional Qualifiers on the same weekend as the National Qualifiers, however, the Qualifier cannot be in conjunction with an Invitational competition*

**VI. 2005 Calendar**

The committee recommends that there be an American Challenge for the 2005 season. If the IEC votes to not have an American Classic for the 2004-2005 season then the NEPC voted to allow the American Challenge to be held in conjunction with an Invitational meet.

*\* The IEC voted to have an American Classic for the 2004-2005 season and therefore the American Challenge will be held in conjunction with the American Classic*

**VII. National Elite Compulsory Program**

**Recommendation the following changes be made in the National Elite Testing Program**

**All landings – must land on feet, no deduction for up to 3 steps backward. (.3 deduction for a fall)**

**Beam 2<sup>nd</sup> pass changed to:** 180 split jump connected to a 180 sissone' (2 foot take off with any foot position) ; one or two steps to a 180 switch split leap; one or two steps hold releve' position on one leg 2 seconds with free leg in optional position; followed by third pass beginning with the back walkover.

**Beam** dismount – clarification, mats must be stacked to the within 6 inches to the top of the beam.

**Floor and Beam** – clarification, 180 degree switch-leap MUST be with straight legs and not a stag switch-leap.

**Floor** – 2<sup>nd</sup> pass, delete “optional entrance” and add **2-3 steps or** chasse' to the cat leap full.

**General Comments/Judging Guidelines:**

**Replace bullet point #6 with,** “Up to 3 steps upon landing on vault, bars and beam dismounts are allowed with NO penalty.”

**Replace bullet point #7 with,** “In order to encourage dynamics, falls on ANY dismount, connection or element will receive a 0.3 penalty.”
