### NOMINATIONS FOR LIFETIME ACHIEVEMENT

Nominees should possess one or more of the following criteria to be a strong candidate for Lifetime Achievement.

- Served a minimum of twenty (20) years in the sport AND whose participation:
  - created or assisted in the development of improved safety standards and enhanced performance at all levels of the sport;
  - assisted in creating a more diverse and inclusive gymnastics community;
  - produced or contributed to research to advance the sport;
  - provided leadership and volunteer service to national committees;
  - served as a judge with a National or Brevet rating and frequently judged at the national and international level;
  - developed gymnastics education as an author, clinician or educator on a national level;
  - or served as a mentor to the gymnastics community.

To be included with the nomination:

- Detailed list of services that indicate years of service and positions held on national, regional and state level committees and/or other volunteer positions.
- Detailed list of examples of publications, articles, clinics conducted and/or presentations/lectures.
- Detailed list of judging services that include national and international assignments.
- Nomination(s) must include a written explanation as to why the nominator(s) believes the individual to be a candidate for the Hall of Fame.
- A minimum of five (5) letters of additional community support, submitted by a diverse set of authors, such as professional peers, athletes, parents, and/or club administrators. Support letter should include a detailed recommendation that not only includes professional accomplishments, but also demonstrates how the individual contributed to provide a safe, healthy and supportive athlete environment.
- If applicable, achievements as a gymnast or coach.
- And any additional information that may support the nomination.
