Elite Committee Meeting Agenda

1. World Championships and WAGC Selection Procedures

The selection process drafted by the Program Committee was submitted for feedback and scores to be added. There was discussion regarding the principles of setting scores for these selection procedures with the uncertainty and unknowns the past year has brought, and it was agreed that Preferential Scores would be similar to previous years' Qualification Scores, and Minimum Scores would be set at or above National Championships qualification scores.

The selection procedures will be provided to the Program Committee for approval.

2. Junior Pan American Games Selection Procedures

The draft selection process was submitted for feedback. No changes were requested. The selection procedures will be provided to the Program Committee for approval.

3. International Assignment Procedures

There was discussion over how to best assign athletes to events in early-mid 2021 (including Jnr Pan Am Champs) with the lack of recent competition results. It was agreed that a session would be run at March National Team camp for athletes to show routines. These will be recorded, and judged if needed.

Due to conflicts of interest within the Elite Committee, the committee agreed to defer the approval of the 2021-2022 international assignment procedures to the Program Committee.

4. Baku World Cup

The committee agreed that this competition should be assigned to the Brescia team, as a preparation for that important Olympic Qualification event. It was noted that 2021 budgets are not yet approved by the Board and final confirmation that we will send a U.S. team will come after that approval is in place.
