1. Age Group Rules 2021-2024

1.1. Tumbling Repetition of Skills

Motion to allow the repetition of elements to line up with the 2017-2021 FIG rules for Youth Elite 11-12 and 13-14 and Junior Elite (15-16).

1.2. Double Mini Repetition of Skills

2. Senior Rules 2021-2024

2.1. Q2 Format

Motion to recommend to the Program Committee that Q2 is held for double mini senior only at USA Gym Champs.

3. Coach/Athlete of the Year Tie Breaker Process

If still tied, both/all athletes and/or coaches will be awarded.
