7. 2023 Pan American Championships and 2023 Selection Procedures

PAGU has published the dates of the 2023 Pan American Championships, which will coincide with the 2023 Elite Challenge. The Committee discussed how to plan for this within the selection procedures, in the fairest and most transparent way possible.

It was agreed to make the following changes to the draft and published documents:

- The four highest ranked Trampoline athletes using the existing assignment process will be

assigned to Pan American Championships. Those athletes will be permitted to decline the assignment if they feel it is not in the best interest of their selection process.

- Trampoline athletes assigned to Pan American Championships will use those scores for all selection processes in the place of Elite Challenge scores. No alterations will be made to scores.
- An additional reason for utilizing discretionary criteria will be added, in the case of two athletes using different meets who are within 0.5 of each other in Combined Score.

Patti and Deanna will work with ProScore and Matt Browne to work out the most similar scoring system possible on ProScore to that used at Pan American Championships, to be used for all 2023 SE and IE selection meets.
