



Call for Expressions of Interest: Trampoline & Tumbling Athlete Representative

Austin White recently stepped down from his position as a trampoline and tumbling representative on USA Gymnastics Athletes' Council. Consistent with the Athletes' Council Bylaws, the Athletes Council will appoint a new T&T athlete representative to serve out the remainder of the term, which concludes at the end of 2019. Alex Renkert is the second elected T&T athlete representative, and he is presently serving a term from 2018-2021.

The Athletes' Council is seeking expressions of interest from T&T athletes who would like to serve as at T&T athlete representative. In other words, we are seeking self-nominations from athletes who are interested in serving the remainder of vacated term, through 2019. Eligible athletes should email aac@usagym.org no later than Friday, March 2 to express interest in serving.

Eligibly requirement for Athlete Representative include:

- Must meet the USOC's 10-year rule (competed in World Championships, Pan American Games, or the Olympic Games within the past 10 years, or have been a member of the Senior National Team in the past two years). A list of the athletes who meet the 10-year eligibility is shown below.
- Must meet the Qualifications for Service outlined in Article 2.4 of USA Gymnastics Bylaws.
- Must be free of safe sport or any other disciplinary sanctions within the last ten years.
- Additionally, the Athletes' Council has been encouraged to consider diversity in gender and T&T event representation.

Responsibilities of an Athlete Representative:

- Will serve on USA Gymnastics' Athletes' Council through 2019.
- Will communicate athlete concerns and issues to USA Gymnastics, as well as communicate information from USA Gymnastics directly to elite athletes.
- If assigned, will serve on program committees, selection committees, and standing committees of USA Gymnastics Board of Directors.
- Will elect one athlete per program to serve as the Athlete Director on the USA Gymnastics Board of Directors. The second athlete in each discipline serves as the Alternate Athlete Director on the Board of Directors, as determined by the Athletes' Council.
