1, 4, 7	Multiple	All references to T210 annual update	Both coaches and judges will be required to take the annual T210 - this will be free for the 2020-2021 competition season and there will be no pass/fail test.
2	8, 9	Timeframe for National Committee voting	The 2020 elections will take place in June-July, 2020. An exact timeframe will be published on the USA Gym website.
2	8, 9	Voting process for Elite Committee Chair, J.O. Committee and Technical Committee	Eligible voters will be as follows: <ul style="list-style-type: none"> <li>• Program Committee Chair: Professional Members of the T&amp;T program (1 vote per member)</li> <li>• Elite Committee Chair: Member Clubs with Elite athletes registered for the 2020 VIP Classic or the 2020 Elite Challenge (1 vote per club)</li> <li>• Technical Committee: Professional Members with a current T&amp;T judges accreditation (1 vote per member)</li> <li>• J.O. Committee: Member Clubs with J.O. athletes registered for Regional Championships (1 vote per club)</li> </ul>
3	5	State requirement to host State Championship	The requirement for each State to host an annual State Championships will not apply for the 2019-2020 competition season.
3	10	Region requirement to host Regional Championship	The requirement for each Region to host an annual Regional Championships will not apply for the 2019-2020 competition season.
4	18	Requirement for meets to use an electronic scoring and display system	Elite mobility meets, national qualifiers (States / Regionals), and selection events are required to utilize an electronic scoring and display system. * (note: for the first and second year of this rule (2020 and 2021 competition seasons), Elite mobility meets and national qualifiers are recommended, but not required, to comply. For the 2022 competition season, all relevant meets must comply).
5	11	Developmental Coach of the Year award	The Developmental Coach of the Year award will not be presented for the 2019-2020 competition season.
6	7	National Team Program	A National Team selection for additional athletes will be made at the 2021 selection event in early 2021. The selection process will be released upon confirmation of the event.
6	10	Voting process for Sportsperson of the Year award	All senior elite T&T athletes who either competed at the 2020 VIP Classic or were registered for the 2020 Elite Challenge will be eligible to cast a ballot for this award. An announcement of presentation location will be made.
6	1, 3	Elite mobility process	A video submission process will be released shortly, for athletes to achieve Elite mobility in late 2020.
7	3, 4	Judges' annual requirements	The following requirements will not be enforced until August 2021: <ul style="list-style-type: none"> <li>• Minimum of in gym observation annually according to category</li> <li>• Minimum of two judging assignments annually</li> </ul>
7	4, 7	Judges' upgrade requirements	The following requirements will not be enforced until August 2021: <ul style="list-style-type: none"> <li>• Minimum of in gym observation annually according to category</li> <li>• Minimum of two judging assignments annually</li> <li>• Failure to maintain annual requirements will result in a loss of your judge's rating.</li> </ul>
7	10	Leader Level requirements	The requirement to attend and judge a minimum of one USA Gymnastics national event per year will not be enforced until August 2021.
7	10	Location for Category 1 exams	Category 1 exams may be given outside National Events until August 2021, as decided upon and approved by the TC based on needs.
