



2019 Trampoline & Tumbling Selection Event Bid Information

If you are interested in hosting a USA Gymnastics 2019 Trampoline & Tumbling Selection Event, bids must be received by January 31, 2018. Please send them to Jordan Dillon at jdillon@usagym.org.

Requirements:

- Selection Events should be conducted in conjunction with an invitational. The preferred weekends are:
 - February 23-25, 2019
 - March 2-4, 2019
- Selection Events must offer at least two sessions for elite competition. During these sessions, no other competition may be taking place.
- The elite competition sessions must be conducted on consecutive days.
- The logo for the invitational may not contain the USA Gymnastics logo. However, USA Gymnastics will provide a tag that must be included with the invitational logo that designates the invitational as a Selection Event.
- The host club will collect entry fees. \$150 entry fee for each elite competitor regardless of the number of events on which they compete. There will be no refunds. The host club will decide to refund an athlete with proof of injury.
- All expenses associated with the competition will be the responsibility of the host club. In addition, the host club must pay expenses (flight, hotel, rental car, food) for one USA Gymnastics representative to be on hand during the competition to oversee the event.
- Competition dates and site must be approved by USA Gymnastics.
- Final competition schedule must be approved by USA Gymnastics. In addition, any changes must be approved by USA Gymnastics.
- The directives for the event must be approved by USA Gymnastics.
- The meet director for the event must work closely with USA Gymnastics to ensure that the event is conducted in a manner that best represents USA Gymnastics and respects the level of competition.
- Webcast, web streaming, and televising of the competition must be approved by USA Gymnastics prior to the event. USA Gymnastics reserves the right to webcast, web stream, or televise the event at its own cost.

- Host must work with the T&T Technical Chair and T&T Program Director to select judges for the event. The requirements must be met as it applies to the judges:
 - All Selection Event panels will be selected and seated by the T&T Technical Chair and both the T&T Technical Chair and T&T Program Director must approve any changes.
 - The judging panel size and configuration must meet the requirements listed in the Elite Code of Points.
 - All travel expenses for Selection Event judges must be paid by the Host.
 - Judges must be paid by the Host in accordance with the “Minimum Pay Scale” found in the T&T Rules and Policies.
- Equipment for Selection Events must be FIG-approved and meet the current apparatus norms provided by the FIG.
- In the case that a non-USA Gymnastics managed Selection Event is not included in any of the 2019 Trampoline & Tumbling Selection Procedures, USA Gymnastics has the right to cancel this contract at no expense or penalty to USA Gymnastics and the host club would have no right to use the term “Selection Event” with regards to their competition.
