 - a. **XCOP** Judges 9.III.G.1. and **Rules and Policies** page 72.III.G.5.a.: **At all sanctioned Xcel competitions for all Divisions,** a coach can request video review by the Meet Referee and the highest rated unaffiliated judge (if video is available) in the event that the inquiry involves possibility that the judges missed an element that would affect the Start Value. The video review process may NOT be used to appeal a judgement of degree assessment, i.e. degree of casts, handstands, incomplete turns, direct connection of elements, or leg separation in leaps as well as other like skills.
